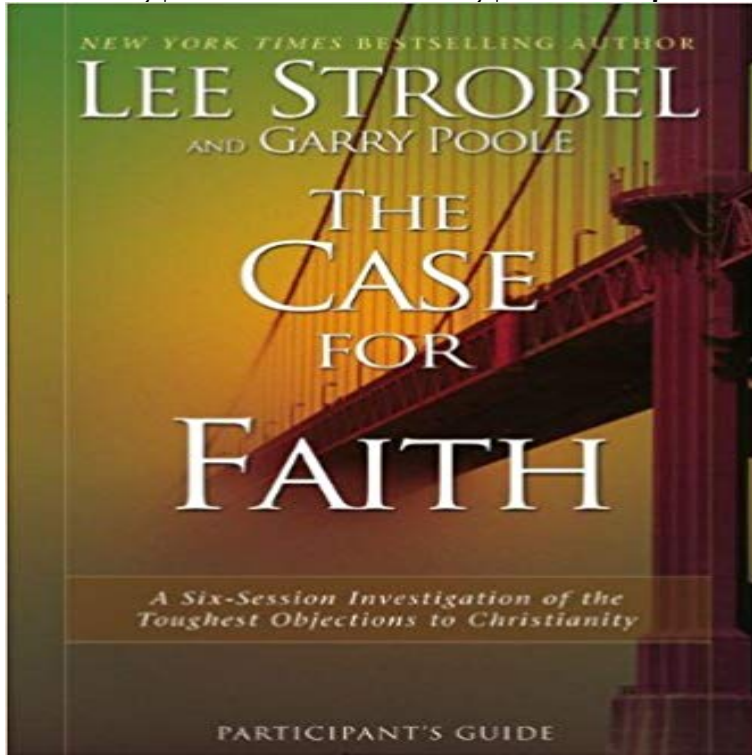


## The Case for Faith Participants Guide with DVD: A Six-Session Investigation of the Toughest Objections to Christianity



In this small group Bible study, *The Case for Faith: A Six-session Investigation of the Toughest Objections to Christianity*, Lee Strobel discusses questions while addressing the most common objections to the Christian faith.
