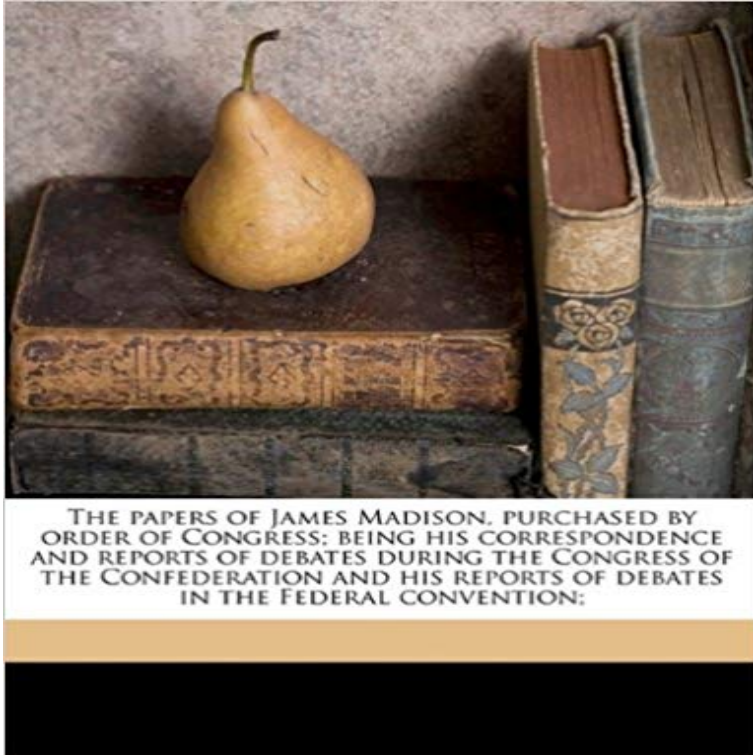


The Papers of James Madison, Purchased by Order of Congress, Being His Correspondence and Reports of Debates.... Volume II
